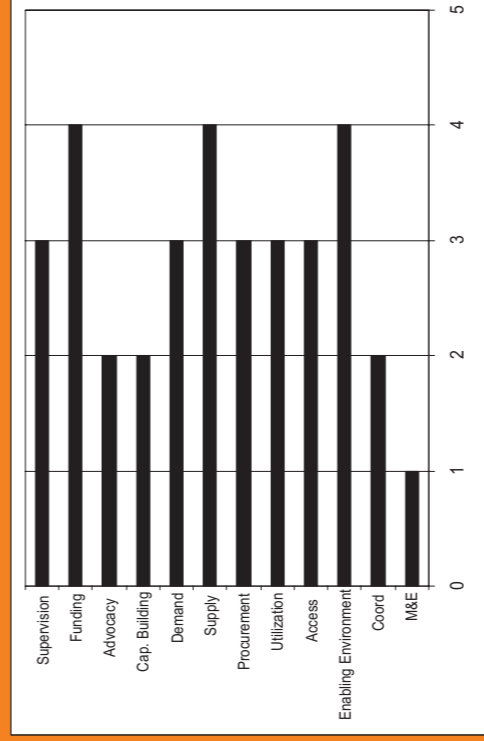

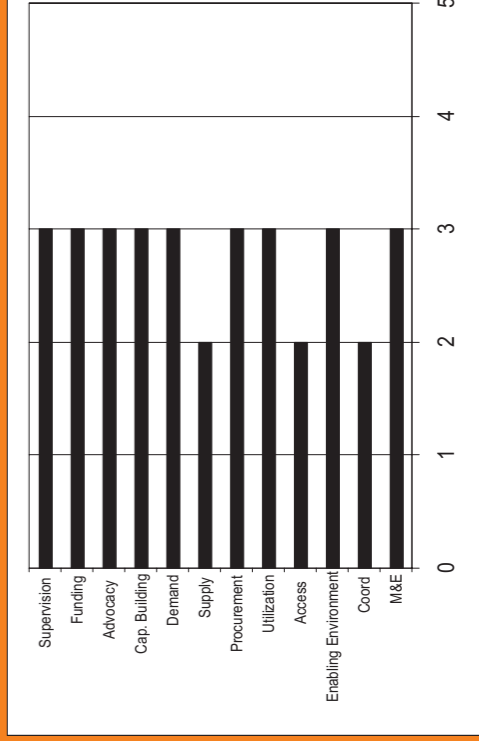
RHCS Assessment (Bangladesh)
